

**KILLIAN PLACE CONDOMINIUM ASSOCIATION
POLICY RESOLUTION 2009-9
PATRIOTIC EXPRESSION**

WHEREAS Article III, Section (1), Paragraph (e), of the By Laws grants the Board "Officer of the Association" specifically conferred upon by the Act, the Declaration, and the By Laws and all other powers and duties necessary for the administration of the affairs of the Condominium Association; and,

WHEREAS Article V, Section (a), grants the Board of Directors the power to amend and adopt rules and policies as outlined in the By Laws and

NOW, THEREFORE, IT IS RESOLVED, The flying of the flag of the United States of America is welcome in Killian Place as a show of support for the armed forces of the United States and our veterans. As per the rules stated in this policy, the display of the United States, US States, and/or other US Military flags and emblems will be allowed.

It is required that unit owners who wish to fly the flag abide by the National Flag Code, approved on June 22, 1942. See www.usflag.org for full details.

Flags flown from the exterior of a unit at Killian Place must also adhere to the rules listed below.

1. Flags flown from poles mounted on units should not touch anything beneath it, such as steps, plantings, etc.
2. Flags should be flown from sunrise to sunset; however, flags may be displayed at night when it is desired to produce a patriotic effect.
3. Flags should not be displayed on days when the weather is inclement except when an all-weather flag is displayed.
4. Flags should never be fastened, displayed, used or stored in such a manner as will permit it to be easily torn, soiled or damaged.
5. Flag size not to exceed: 36" x 60" and shall be hung from a pole, not to exceed 6' in length, that is attached to the unit.
6. Flags that are not in good repair must be removed and disposed of properly.

As per the Board of Directors of Killian Place, for a period of 180 days from the date of this resolution, no restriction contained in the governing documents prohibiting the display of the flags shall be forced against any resident of the Association to the extent that residents may display one removable flag as stated herein.

Said moratorium is extended automatically for an additional 180-day period until revoked by the Board and then it shall expire 180 days from the date hereof and governing documents shall thereafter control and prevail.

This resolution is adopted and made part of the minutes March 10th , 2009
